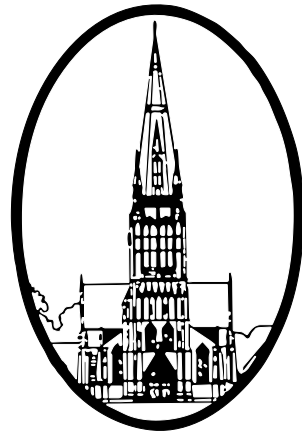

Mission Statement and Values

The School operates the following policy on its website regarding the use of photographs, to ensure the privacy and safety of pupils at the school:

- Where pupils are named, only their first names are given;
- Where a pupil is named, no photograph of that pupil is displayed;
- Where a photograph is used which shows a pupil, no name is displayed

By observing these points, the school ensures that visitors to the website cannot link images of pupils to names of pupils. When choosing photographs for the website, the school is mindful of the way pupils may appear in them, and will not include images which are in any way inappropriate, such as close up or portrait shots of individual pupils.

The school follows a policy of seeking parent's permission to use their child's images which show pupils on the website. This is done via our policy of regularly sending parents a data collection sheet of which is a permission request for trips/visits, use of the internet and use of photographs.

Consent sought from parents/carers for the permission to use their child's images is also sought at the admissions meeting.

The school's aim is to celebrate achievement and enjoyment, if we have published any image which causes concern to a parent or child please inform us and we will remove the image without debate.

No other private information about pupils is ever published on the website such as surnames or contact details.

Website Privacy Policy

We are committed to safeguarding the privacy of our website visitors; this policy sets out how we will treat your personal information.

1. What information do we collect?

We may collect, store and use the following kinds of personal data:

- Information about your visits to and use of this website;
- Information about any transactions carried out between you and us on or in relation to this website.
- Information that you provide to us for the purpose of registering with us, and/or leaving guestbook comments, and/or subscribing to our website services and/or email notifications.

2. Information about website visits

We may collect information about your computer and your visits to this website such as your IP address, geographical location, browser type, referral source, length of visit and number of page views. We may use this information in the administration of this website, to improve the website's usability, and for marketing purposes.

We use cookies on this website. A cookie is a text file sent by a web server to a web browser, and stored by the browser. The text file is then sent back to the server each time the browser requests a page from the server. This enables the web server to identify and track the web browser. We may send a cookie which may be stored by your browser on your computer's hard drive. We may use the information we obtain from the cookie in the administration of this website, to improve the website's usability and for marketing purposes. We may also use

that information to recognise your computer when you visit our website, and to personalise our website for you.

Most browsers allow you to refuse to accept cookies. (For example, in Internet Explorer you can refuse all cookie by clicking "Tools", "Internet Options", "Privacy", and selecting "Block all cookies" using the sliding selector.) This will, however, have a negative impact upon the usability of many websites.

3. Using your personal data

Personal data submitted to this website will be used for the purposes specified in this privacy policy or in relevant parts of the website. In addition to the uses identified elsewhere in this privacy policy, we may use your personal information to:

- Improve your browsing experience by personalising the website;
- Provide other organisations with statistical information about our users – but this information will not be used to identify any individual user.
